- C. The Space Coast Art Festival will have the exclusive sale of all alcoholic beverages, unless approved by the Board for a vendor to sell a specific beverage.
- D. Food Vendors may only sell items agreed to by this contract. Food items must not directly compete with The Avenue® Viera tenants. Menu items and truck/cart must be approved by The Avenue® Viera prior to participation.
- E. I understand and agree to the following conditions:

IF THE EVENT IS CANCELED PRIOR TO THE DESIGNATED START TIME Vendors have the option of receiving full credit for the next scheduled event or a refund of their vendor fees. IF THE EVENT IS CANCELED AFTER THE DESIGNATED START TIME Vendors who have checked-in will be awarded credit for the next event. No refunds will be given for events canceled after their designated start time.
